MULTI-SECTOR NATIONAL PLAN



ANALYSIS WORKSHOP ON THE INSPECTION REGULATIONS



A proposal for a ministerial order for the creation of the national institute of public health was reviewed by the Ministry of Health, Hygiene and Prevention from June 23 to 24 2022. It is now in advanced stage of negotiations for the creation of this institute that will put in place experts in the management and transformation of public health actions at the intermediate and peripheral levels. It will also contribute to the realization of universal health coverage. This initiative is being led by the DRC General Directorate for Disease Control (DGLM) with support from Jhpiego.

HEALTH EMERGENCY MANAGEMENT TECHNICAL WORKING GROUP

Jhpiego is an essential part of this group and is a co-facilitator.
